3. Check specification

For harmonization with IMDS, a check JAMA sheet's check specification has been changed. (The date of IMDS change is 19th November, 2015.)

Changes in the check condition of the Item "Polymeric Parts Marking" in IMDS

- Range of VDA classification to be checked is changed (only 5.1.x, 5.3 -> 5.x)
- Check of the 25g part weight threshold is removed*

*: There is no effect for JAMA Sheet because this '25g' check has not been equipped.


After November 1st, to create MDSs with ver.2.32 is recommended independent on IMDS release date (November 19th) is recommended in order to reduce errors at upload timing to IMDS.

4. Material list

A part of Material description below is changed to harmonize with IMDS recommendation. The old description of the material will be removed from the external list after around a year as extension period. Then the old description will be treated as error in the check.

5. Substance list

On and after the last upgrade, BPR related substances have been added. Please note that special statements for treating these substances are written in the GADSL reference list.

Allocation of GADSL classifications for "Biocidal coatings / biocidal additives, selected":

- Allowed to use: "D",
- -Prohibited in one or more purposes (Product Type): "D/P"



In JAMA/JAPIA standard material data sheet shows even these substance names as "Brown for D, Purple for D/P and Red for P" simply according to GADSL classification. These substances may be treated as exemption depending on conditions.



(Supplemental remarks) Data compatibilities between Old versions and Ver. 2.32

(1) External List

Not compatible

Users must use the external list Ver.2.32.

The external list of Ver. 2.31 or older cannot be used because some of functions, such as material selecting function, doesn't work properly.

(2) CSV file

Compatible (Not compatible under a specified condition)

The JAMA Standard Material Datasheet can import CSV files created by older version sheet (From Ver. 2.01 to Ver. 2.31)

However some errors may occur because of the modification of materials and substances in the new external list.

In case of errors, the data has to be corrected.
